SHOSHONE SCHOOL DISTRICT #312 TRUSTEE ZONE NO. 2

BEGINNING at the west district boundary and its intersection with US Hwy 26; East northeasterly on US Hwy 26 to the point where the district boundary departs US Hwy 26 to the east; East on the district boundary then north a short distance to US Hwy 26; East on US Hwy 26 to the city limits of the city of Shoshone. Northeasterly on the city limits to the Little Wood River; Easterly on the Little Wood River to Grape St.; North a short distance on Grape St. to St. North; Easterly on 5th St. North becoming Elm St. to 4th St. North; East on 4th St. North to Cherry St.; South on Cherry St. to 3rd St. North; and East on 3rd St. North to an alley located between North Alta St. and said North Beverly St., thence South along said alley crossing East 2nd St. and continuing South approximately 600 feet to the Little Wood River, thence Easterly along said Little Wood River approximately 150 feet to N01th Beverly St., thence South on said North Beverly St. approximately 110 feet to US Hwy 26, thence

Westerly along said US Hwy 26 approximately 0.2 miles to Greenwood St., thence Southwesterly along said Greenwood St. approximately 230 feet to South Rail St., thence Southeasterly along said South Rail St. approximately 600 feet to South Beverly St., thence Southerly along said South Beverly St. approximately 0.5 miles to a point approximately 330 feet south of the intersection of said South Beverly St. and State Hwy 24, thence West from said point approximately 850 feet to US Hwy 93, thence Southwesterly along said US Hwy 93 approximately 5.5 miles to the District Boundary and the Lincoln-Jerome County line, thence west, then North on the District boundary to the POINT OF BEGINNING.
